08/24 MINUTES:

Teigngrace Highways: Drainage at Ley Green. Large puddles and drainage issues. Drainage issue reported again today, appears clear on the other side of the hedge. {14/11/2023}

Tree at Ventiford Basin: Land between Ventiford Brook and Ventiford Basin is not owned by anyone. A Gale has asked National Grid and S. Adams has asked D.C.C. Footpaths if they will remove the tree.

National Grid replied "With regards to the tree at Ventiford - we would happily provide isolation on the low voltage line, but we wouldn't provide any tree cutters. If they want to get this taken down, their best bet is to organise it themselves with a tree contractor, if the tree contractor is worried about the low voltage line then they can contact national grid. We did speak to another guy possibly from the canal trust? And we relayed this information to him." The bulk of the tree has now been removed. {14/11/2023}

Airband Installation – Summer Lane: The pole location markings are close to the highway and will narrow the road.

Airband replied "I have looked at the Work Pack WP2829 and identified the poles in question. I have forwarded to the Project, Civil, and Planning Teams for their review and highlighted your comments below.

I also understand that there is a hold on this work pack at the moment as one of the poles in it also required a Wayleave agreement, so the work is not imminent at this time." {02/01/2024}

Construction of a shared use path with crossing, and any associated landscaping, drainage and earthworks at A382, Stover School Junction, TQ12 6QG
