Proposal: Town and Country Planning General Regulations 1992 - Regulation 3 Variation of Conditions 4, 9, and 11 of permission DCC/4131/2019 (Provision of a new link road connecting the A382 to West Golds Way at Land between the A382 and West Golds Way near the Newton Abbot Hospital, TQ12 2TS) at Land On North Side of West Golds Way, Newton Abbot, Devon TQ12 2TS.

The County Planning Authority has received a planning application for the above proposed development. The application was received on 09/11/23 and the target date for determination is the 08/02/24.

The application for the variation of condition seeks to amend the wording of conditions 4, 9 and 11 to change 'No part of the development shall commence' to "No development, except for the removal/clearance of vegetation, shall commence'. The application solely relates to the change of wording in the conditions and does not seek to change the scheme itself, hence why there is no attached information with the application.

The following Conditions to be amended: Condition 4 (temporary drainage), Condition 9 (offset planting), Condition 11 (design of culvert).
