Transport: The existing junction with A382 is dangerous with poor visibility. There does not appear to be any detail regarding improvements to this access which we feel is required given the extra 563 trips being generated by the expansion in pupil numbers.

The Speed Limit on the A382 is 60mph, not 40mph as stated in section 3.7 of the Transport Assessment.

Stover Drive (Templar Way) use was discussed at the Public Consultation Event and the Parish Council Representatives were told that there were no plans to continue to use this for

vehicular access. This is not stated in the Planning Application. We would like this added, excepting Emergency Access.
